

Child acceptance at the Institute

Institution: Ministry of Social Affairs (National Institute of Child Protection).

Service: Social Promotion.

Field of Service: Deposit at the National Institute for Child Protection.

Conditions for the service

- Children aged between one day and 6 months.
- Deposit authorization of Family judge or a request from child protection officer or an authorization from the Ministry of Interior and Local Development departments.
- An instant report filed by the Ministry of Interior and Local Development departments (in case of a direct request from the mother).

Required Documents

- 1) An instant report filed by the Ministry of Interior and Local Development departments (in case of a direct request from the mother).
- 2) The child birth certificate
- 3) The child's health booklet.
- 4) A medical certificate on the health status of the child.
- 5) A copy of the national identity card of the mother or her tutor, and of the father in case of his availability.
- 6) View of the case by the social assistant undertaking the situation.
- 7) Report of the child protection officer.

Date of providing the service

- Immediately after submission of the deposit request in emergency cases and on a fixed appointment in the other cases.
- Immediately after submission of the deposit request or its authorization when there is a vacancy in the living units.
